

GLYPHOSATE PRO™ 4

A BROAD-SPECTRUM, SYSTEMIC, NON-SELECTIVE POSTEMERGENCE HERBICIDE FOR TURF, ORNAMENTAL, AND INDUSTRIAL WEED CONTROL

PROKōZ GLYPHOSATE PRO™ 4 is a postemergent, systemic herbicide with no soil residual activity. It provides broad-spectrum control of many annual weeds, perennial weeds, woody brush, and trees. GLYPHOSATE PRO™ 4 is a water-soluble liquid containing surfactant for convenient spray application.

Active Ingredient

Glyphosate (isopropylamine salt).....41.0% / 4 lbs. per gallon active

Application Sites

This product moves through the plant from the point of foliage contact and into the root system. Visible effects on most annual weeds occur within 2 to 4 days and on most perennial weeds within 7 or more days. However, extremely cool or cloudy weather following treatment may slow activity and delay development of visual symptoms.

Reduced control may result when applications are made to annual or perennial weeds that have been mowed, grazed, or cut, and have not been allowed to re-grow to the recommended stage for treatment. Reduced results may also occur if water containing soil or other organic matter is used, such as visibly muddy water or unclear water from ponds and ditches.

Heavy rainfall or irrigation soon after treatment may wash this product off the foliage requiring a repeat application for adequate control.

This product does not have any soil activity. Weeds must be emerged at the time of application for control.

GLYPHOSATE PRO™ 4 is non-volatile. Therefore, it cannot move as a vapor after application to affect nearby vegetation.

Application Rates

Various application rates apply depending on use. Normally, use 1 to 5 quarts per acre, or about 1-2% solution for hand-held, spray-to-wet applications. Refer to complete label for specific application rate instructions.

Re-entry Intervals (REIs)

Agricultural Use Requirements: 4 hours

Non-Agricultural Use Requirements: Do not allow entrance to treated areas until spray has dried.

Benefits

- Provides broad-spectrum control of many annual weeds, perennial weeds, woody brush, and trees
- Excellent for use prior to turf renovation or to establish turfgrass grown for seed or sod
- Controls labeled perennials as a substitute for (chemical) mowing
- Controls labeled woody brush and trees by injection, frill application, or cut stump treatment
- Can be applied to labeled dormant turfgrass for effective weed control
- Can be used as a trim and edge application around objects in non-crop settings
- High-quality, water-soluble liquid containing surfactant for convenient spray application
- Conveniently packaged in 2 x 2.5 gallon cases and 30 gallon drums

Important
